

# Flexipel HR-C200

Nonfluorinated Water Repellent

#### **Overview**

- Nonfluorinated water repellent developed for use on fabrics and carpets, as well as concrete and stone surfaces
- Fabric substrates include polyester, cotton, cotton/polyester blends, and nylon twill
- Water Repellency ratings of 3-4 on fabric substrates such as 100% cotton, 100% polyester, and cotton/polyester blends
- Water Repellency ratings of 3-4 on carpet substrates such as nylon 6 and nylon 6,6
- Repellent treatments can be achieved on concrete, Saltillo tile, and tumbled marble
- Heat cure is recommended for textile applications
- Non-flammable
- VOC free

### **Applications**

- Treatment of textile substrates such as cotton, polyester, cotton/polyester blends, nylon twill
- Treatment of carpet substrates such as nylon 6 and nylon 6,6
- · Treatment of concrete
- Treatment of stone surfaces such as Saltillo tile and tumbled marble

#### **Technical Information**

Flexipel HR-C200 is a cationically stabilized aqueous polymer emulsion which imparts water repellency to fabrics, concrete, and certain stone surfaces.

Wash durability of fabrics can be improved by co-applying Flexipel HR-C200 with Flexipol DMP-20.

### **Formulary**

Flexipel HR-C200 is diluted for use, with a recommended starting point of 4% (as delivered) in water. Heat cure is recommended for textile applications.

Wash durability on fabric substrates can be improved by co-application with Flexipol DMP-20. Prepare an aqueous formulation containing 4% (as delivered) of Flexipol DMP-20. Heat cure is recommended.

Fabric applications of dip/nip or spray are recommended, followed by heat cure

For concrete or stone surfaces, application techniques of brush, roller, or spray are recommended.
